3. I expressly waive and relinquish any and all claims against Bark Place LLC, its employees and representatives, except for those arising from negligence on the part of Bark Place LLC.
4. I have disclosed to Bark Place LLC all known dangers associated with my dog.
5. I expressly understand and agree that Bark Place LLC shall not be held responsible for any damage to my property beyond the replacement value of my dog.
6. I understand that under no circumstances will Bark Place LLC be liable for consequential damages or damages beyond the replacement value of my dog.
7. If any medical problems develop while my dog is in the care of Bark Place, I authorize Bark Place LLC to do whatever is necessary for the safety, health and well being of my dog. Further I assume full financial responsibility for any and all expenses incurred.
8. I understand that the day care service Bark Place LLC provides is in an open, cage-free environment. I accept the risks involved and agree Bark Place LLC is not liable for any injuries or illness resulting during my dog's attendance.
9. I hereby declare to Bark Place LLC that I am the legal owner of my dog; that my dog has not been exposed to distemper, rabies or parvo within the last (30) thirty days; that my dog has been inoculated as indicated by records presented; that my dog is currently and properly licensed; I (the owner) have completed the Bark Place LLC guest profile for my dog and certify the information I have provided to be true and accurate; and I (the owner) have read this agreement in it's entirety.

### Payment Requirements

1. I understand that in order to reserve my dog for daycare or boarding, I need to pay for services in advance.
2. I understand the hours of operation are Monday through Friday 6:45 AM – 6:30 PM and a \$10 late fee charge is applied at 6:31 PM and 6:46 PM. In the event I do not pick my dog up 7:00 PM, Bark Place reserves the right to charge me for an Last Minute! Emergency overnight boarding at the most current rate listed.
3. I understand the hours of operation Saturday are 8:30 AM – 3:00 PM and a \$10 late fee charge is applied at 3:01 PM and 3:15 PM. In the event I do not pick my dog up 3:00 PM, Bark Place reserved the right to charge me for an Last Minute! Emergency overnight boarding at the most current rate listed.
4. If I purchase a ½ day service and fail to pick up my dog by 3:30 I will be charged for a full day. If I fail to pick up my dog by closing late fees will apply (see # 2).
5. I authorize Bark Place LLC to charge my credit card for any outstanding balance.
6. I understand that if an unpaid balance remains for more than 60 days, unless other arrangements are made, my account will be turned over to a collection agency and that as a result I will be liable for collection costs and attorney fees in addition to the unpaid balance.
7. I understand Bark Place has the right to refuse service to me and my dog at any time for any reason.
8. I understand Bark Place will charge me a \$25 handling fee for returned checks.
